To be applied pure on completely dry and clean surfaces, using a paintbrush, cloth, sponge. For best results, on most absorbent surfaces, apply wet on wet, making sure to apply the amount that the material naturally absorbs evenly, avoiding the direct sunlight and the temperature of the material above 30 degrees. If applied in excess, a sticky surface film is created. After a few seconds after application, remove the product in excess not absorbed, with a clean cloth or sponge. Desired protection is reached 24 hours after treatment. After application, do not step on the surface, for 4-6 hours.
